Option 2: Employee Handbook Builder – For employers interested in an employee handbook builder that ensures not only federal but multi-state compliance. Includes federal plus all states and can be customized to reflect your culture, add your own policies, etc. As laws change, the template is updated by Zywave and users are notified so they can choose whether to view and apply them.
